

## Understanding How Outpatient Counseling and Therapy Reimbursement Is Calculated for Those Without Insurance

### Reasonable and Customary, Using FAIR Health 80% Benchmark

Using the provider's ZIP code for reference, JND Legal Administration will apply data published by FAIR Health<sup>1</sup> to establish reasonable and customary (R&C) benchmarks. FAIR Health provides data by geographical locale, broken down by percentiles. The calculation is made by cross-referencing ZIP code and service code at the 80<sup>th</sup> percentile.

#### Example

If 80% of providers in ZIP code 48823 charge \$150 for a 45-minute psychotherapy session (service code 90834), JND Legal Administration will allow \$150 or the provider-billed amount, whichever is less.

To further clarify, if a provider in ZIP code 48823 charges \$500 for a 45-minute psychotherapy session, JND Legal Administration will not allow 80% of the billed amount (\$400). JND Legal Administration will allow \$150, which is the established FAIR Health benchmark charged by 80% of providers in ZIP code 48823 for the same 45-minute psychotherapy session.

- Provider A charges \$150 for a 45-minute session. With proper documentation, an uninsured survivor would be reimbursed \$150 since it equals FAIR Health's benchmark charged by 80% of providers in the geographical area.
- Provider B charges \$94 for a 45-minute session. With proper documentation, an uninsured survivor would be reimbursed \$94 since the provider's rate is less than the FAIR Health benchmark charged by 80% of providers in the geographical area.
- Provider C charges \$300 for a 45-minute session. With proper documentation, an uninsured survivor would be reimbursed only \$150 since the provider's rate exceeds the FAIR Health benchmark charged by 80% of providers in the geographical area. The survivor will be responsible for the balance of fees charged by the provider.
